This contract is for the above described boat only. Contracts cannot be transferred or assigned. In the event that the above boat is sold or transferred in any manner whatsoever except to a corporation of which the undersigned is the sole shareholder, this contract is terminated immediately and no refund will be issued.

1. It is understood and agreed that all summer and winter storage and any and all other charges are to be paid when billed.
2. Boats not launched or removed from LASALLE YACHT CLUB by JUNE 21st will be billed for Summer Storage.
3. Boats will not be removed from the water if a STORAGE CONTRACT is not completed and signed.
4. Boat owner must supply their own cradle and/or blocking and have their own crew available at time of launch or haul-out.
5. Travel lift sling locations must be clearly marked on boat.
6. BOAT OWNER agrees to maintain proper liability and property insurance at all times vessel is at LASALLE YACHT CLUB.
7. BOAT OWNER acknowledges that they have read and understand the “Boating Rules” and “Storage Yard and Slip Maintenance Responsibilities” revised January 2004. BOAT OWNER furthermore acknowledges violations of the “Boating Rules” and “Storage Yard and Slip Maintenance Responsibilities” may result in termination of contract with 24 hour written notice and without refund.
8. LASALLE YACHT CLUB is not liable for loss of any property, or for any personal injury or death on account of fire, flood, theft, vandalism, hurricane, tornado or any other cause whatsoever, notwithstanding that any such event may have been caused by the negligence of LASALLE YACHT CLUB or any of its agents or employees and the undersigned BOAT OWNER releases, discharges and covenants not to sue LASALLE YACHT CLUB, its officers, agents and employees, from any and all claims and liability arising out of strict liability or ordinary negligence of such parties which causes the BOAT OWNER injury, death, damages or property damage. The BOAT OWNER covenants to hold LASALLE YACHT CLUB harmless and indemnify LASALLE YACHT CLUB for any claim, judgment or expense which LASALLE YACHT CLUB may incur arising out of the BOAT OWNER’s activities or presence on LASALLE YACHT CLUB’s property.
9. The BOAT OWNER further agrees to save, indemnify and hold harmless LASALLE YACHT CLUB from any claims or damages whatsoever by reason of injuries, death, damages incurred by any guest or invitee of the BOAT OWNER and with respect to any property damage or loss sustained by any guest or invitee of the BOAT OWNER. The BOAT OWNER further hereby waives any right of subrogation on behalf of itself and all parties that may derive rights through the BOAT OWNER as a result of any injuries, death, damages or property damage with respect to which the BOAT OWNER may have become liable. We recommend the removal of all loose items, including all electronics and props prior to winter storage.
10. If the BOAT OWNER shall fail to pay rent due hereunder, or to remove the boat as required hereunder under the terms hereof, the BOAT OWNER shall be liable for all rentals due and additional costs and expenses incurred by reason of the BOAT OWNER’s default, and further, will pay to LASALLE YACHT CLUB reasonable attorney’s fees incurred by reason of the BOAT OWNER’s default. In addition to all rights and remedies otherwise allowed by law, LASALLE YACHT CLUB shall have the right to sell said boat either at public or private sale or auction after 10 days written notice to the BOAT OWNER, deducting all unpaid rentals, occupancy rates, charges, costs and expenses from the sale proceeds thereof and remitting the balance thereof to the BOAT OWNER.
11. REQUESTS FOR WINTER OR SUMMER STORAGE WILL NOT BE HONORED UNLESS ACCOMPANIED BY A CURRENT COPY OF THE VESSEL’S FEDERAL DOCUMENTATION OR NEW YORK STATE REGISTRATION!
